Course description

Focusing mainly on the novel and autobiography, the aim of this course is to introduce students to a new generation of Francophone African writers. We will explore the ways in which writers engage with contemporary African experiences in and out of the continent, and examine the new literary forms and practices that transform the production. The objective of the course is to understand the topics, ideas and innovative representations of Africa and its diaspora proposed by these writers. Authors include Fatou Diome, David Diop, Gaël Faye, Camara Laye, Alain Mabanckou and Léonora Miano.

Assignments

Book chapters, excerpts and articles (indicated by the instructor) should be read before the beginning of the session.

Each student is required to write two essays on a topic that will be announced in due time. Students are also required to write a final paper on a topic of their choice. The topic should be discussed with the instructor before submission of the proposal. The final paper should be a research paper. All the works have to be submitted on the class canvas site by the date indicated by the instructor.
